<p>Filing requirements are per state statute, available on the Texas Secretary of State website, and those of the City of Manvel Charter, Article VI, (Charter Qualifications - Candidates . Each person who becomes a candidate for mayor or councilmember shall meet the following qualifications:</p> <ol style="list-style-type: none"> 1. Be at least twenty-one (21) years of age on the first day of the term to be filled at the election 2. Be a citizen of the United States 3. Be a qualified voter of the city 4. At the time of the election, and for at least twelve (12) consecutive months preceding the election, shall reside within the corporate limits of the city 5. No candidate may file for more than one (1) office or place number per election 6. Must not have been convicted of a felony or any offense involving moral turpitude. 	<p>February 13, 2026 by 5:00 p.m.</p>

Candidates are strongly encouraged to obtain a candidate packet.
